	<p>Lindsay Dodsworth, Chair Governor since Sept 2021</p> <p>Lindsay Dodsworth is a Non-Executive Director of an investment trust and a venture capital trust and a trustee of Goodenough College. She was formerly the Chair of a Family Office which she set up with the founders and oversaw the evolution of its business and charitable activities. She read music at Trinity Hall, Cambridge before qualifying as a Chartered Accountant and Chartered Tax Adviser with Price Waterhouse and then became an international tax partner at EY.
